“There’s no doubt that NorthPointe and Beloit Health System saved my life.” Those are the words Diane Richter, 68, emphasizes when talking about her dramatic health experience last October. Thanks to the kind concern of a stranger, the quick response of NorthPointe Wellness staff, the immediate reaction of a highly trained emergency team and the expertise of Dr. Leo Egbujiobi, Diane’s story has a happy ending.

After her first day of aqua aerobics at NorthPointe Wellness, Diane returned to the locker room. Her jaw and head hurt, and her arms were like lead weights. Another member sensed her distress, put her arm around her, and called instantly for help. Fortunately, NorthPointe’s Immediate Care staff was right there. The team stabilized Diane and sent her in an

ambulance to Beloit Hospital, where Dr. Egbujiobi and his heart and vascular team awaited her arrival.

Diane’s right coronary artery was 100 percent blocked, so doctors performed an angioplasty. “The hospital team really knew what they were doing. I give them credit for caring so much and taking care of me.”

After a few days in the hospital, Diane was home and making plans for cardiac rehab at the hospital and NorthPointe Wellness. She looks forward to getting back in the pool for her aqua aerobics with a renewed commitment to take care of her heart.

Keith Shorter, 53, never anticipated he'd have cancer. When his gastroenterologist, Dr. Tsu-Hon Wang, confirmed Keith's symptoms of weight loss and discomfort indicated colorectal cancer in 2012, Keith knew it wouldn't be easy.

"Before doctors could remove the tumor, I had to undergo seven weeks of radiation and chemotherapy. Dr. Peter Mahler, Dr. Walter Vogel [oncologists] and their team made it as positive as they could for me."

"My type of cancer is usually found in older people, and I asked them to be very honest with me. I didn't want a sugar-coated answer. I needed to know what I was dealing with." Keith now considers Dr. Mahler a good friend, but remarks, "Having cancer is a tough way to meet a new friend."

Although Keith's cancer has slowed him down a bit, he remains very optimistic about life. "I'm lucky to have good doctors who've helped me every step of the way with my challenges."

Keith sees Dr. Mahler regularly for annual follow-ups and just to visit. "I would do anything for Dr. Mahler. Besides giving me hope, he's helped me stay around a little longer for the three women in my life – my wife and two daughters."

Life is busy. That's why Dianna LaFon, 44, waited so long to get hip replacement surgery. "I've been limping for years now, but didn't take the time to figure out why until last fall," Dianna said. She heard such good feedback about Dr. Brian Keyes, orthopedic surgeon, she decided to go to NorthPointe and get his professional opinion.

Dianna is a busy ER/ICU nurse in Rockford and is sometimes on her feet 12 to 14 hours per day. When she could no longer take care of herself, she knew it was time to get some help. "I have nothing but good things to say about Dr. Keyes, the quality of his skills and my experiences at Beloit Hospital and NorthPointe. In fact, I have to say I'm feeling awesome!"

Dianna can't wait to be active again, hitting around a few tennis balls, playing golf or walking. After replacing both hips – one in January and one in March – Dianna is on her way to recovery. Each surgery required three days in Beloit Hospital, two weeks of in-home therapy and two weeks of physical therapy at NorthPointe.

"I have so many people to thank: Dr. Keyes, my physical therapist, Megan, and all the others who took such great care of me. I'm excited people will no longer have to ask why I'm limping."

Moles aren't always harmless. Such was the case for Matt Schmidt, 56, who casually mentioned the mole on his leg to Dr. Robert Lisek, NorthPointe internist, during a routine checkup.

"I didn't make the appointment specifically for the mole. I was just being proactive and wanted to have an annual checkup. After evaluating the mole last fall, Dr. Lisek insisted I see a dermatologist."

Dr. Roger Kapoor, dermatologist, biopsied the mole and determined it was melanoma, the most dangerous form of skin cancer. (The National Cancer Institute indicates that 20 percent of the melanoma patients between the ages of 55 and 64 die from this disease.) NorthPointe's new dermatology clinic

assists patients with all skin concerns from medical dermatology to cosmetic services. Matt had the mole removed by Dr. Kapoor at Beloit Clinic and had a follow-up visit with Dr. Walter Vogel, an oncologist. "They gave me plenty of information and options. Since the cancer was a surprise to me, they really helped me understand and gave me a clean bill of health."

"I feel very lucky. Whether it's repairing my shoulder pain with Dr. Ken Klein, physiatrist, or removing my skin cancer, all the doctors at NorthPointe have taken very good care of me."
